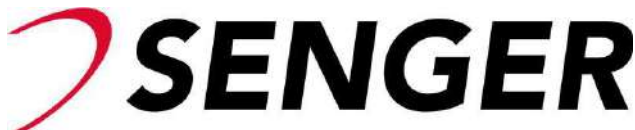

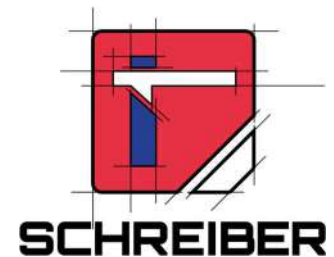

4. COMPETITION SITE



Wasserskiclub Bremerhaven e.V. – where water-skiing has tradition and the future takes off
When you waterski in Bremerhaven, you’re riding on historic water. Between 1955 and 1965, enthusiasts were already meeting on the River Lune—right where our course is located today, in the

Luneplate area. Back then, you got there via a dirt track through Lanhausen, and the “club grounds” were a wetland surrounded by farmland. It was improvised—but driven by huge passion.

In 1965, Wasserskiclub Bremerhaven was officially founded. Under basic conditions, the first small club hut was built, and waterskiing was mainly a leisure activity—boats still towed skiers with outboard engines. But the sport quickly gained momentum: around 1975 we entered our first competitions and realized that serious training

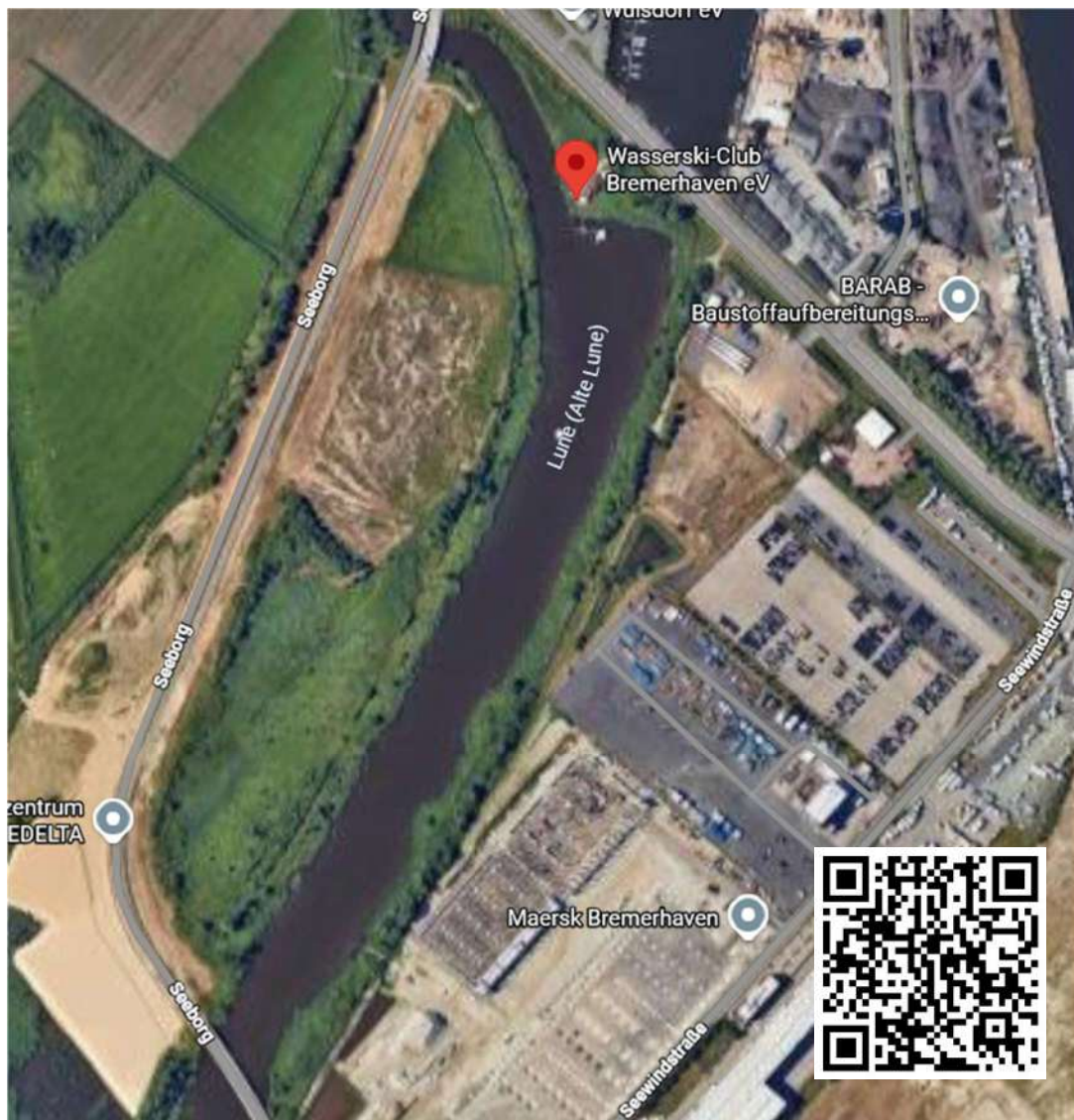
needed a proper towboat. Soon after, we acquired our first ski boat—a Boesch—and that marked the next step toward competitive water-skiing. Over the following decades, competitive waterskiing steadily grew. Especially in the 1990s and 2000s, we hosted many events—and we continue to do so today, backed by the experience of



the last 25 years. Before 2010, industrial development plans and road construction forced us to leave our former site and move to our current location. With strong support from the City of Bremerhaven,

its institutions, and committed local companies, we were able to build a new club facility here -- including docks and a boathouse.

What makes us special: we keep our competition setup consistently up to date—slalom course, jump ramp, and everything that comes with it. Today, the club has around 50 members, and alongside training and club life we also run holiday sports programs, guest runs, and plenty of activities on and around the water. In short: Bremerhaven isn't just a venue—it's a place where waterskiing is truly lived.

6. HOW TO REACH HOTEL AND THE SITE

There are plenty of ways to reach Bremerhaven in a easy and fast way:

By plane:

The nearest airport is BREMEN. The journey to Bremerhaven takes about one hour. Alternatively, there is an airport in HAMBURG. From there, it takes about two hours to drive. You also can take a train from both airports to Bremerhaven.

By train:

The main station of Bremerhaven is in the middle of Bremerhaven. There are taxis to take you to your hotel.

By car:

Enjoy the freedom on German highways with no speed limits. There are plenty of rental companies at the airport which has big, small and really fast cars. It's recommended to take full insurance on all rental cars. Please don't drink and drive! The limit is 0,5 alcohol level.

7. CURRENCY

In Germany, "cash is king" is more than just a saying. It is the way life works. Expect to become very familiar with ATMs and euros as you travel through this fascinating country.

At the cable park you can pay in cash in Euro, PayPal, Apple Pay and all common credit & Debit cards.

8. VISA REQUIREMENTS

Please check entry requirements for your country or contact German Embassy in your country. German visitors arriving at an airport from a foreign country need a passport. EU nationals do not need a visa, others may need one depending on length, frequency and purpose of their stays.

EU-Nationals

EU nationals do not require a visa to enter the Federal Republic of Germany.

Non-EU nationals

Generally speaking, all other foreigners require a visa for stays in Germany. A visa is not required for semi-annual visits of up to 90 days each for nationals of those countries for which the European Community has abolished the visa requirement.

12. ENTRY AND ADMINISTRATION - E&A Waterski Additional Rules 2026 - (V2)

Each Federation shall declare, through EMS, not later than **45 days** before the scheduled start of the first event of the Championships:

- The names of the members of its team
- The names of the competitors entered as “Individuals”
- The names of the competitors entered as Wild Cards
- The names of the Official reserves.

For each competitor registered, the events that they will compete in together with the ramp height for Jump needs to be entered.

An entry is considered complete when the Skier’s name is registered in EMS and the full Entry Fee Payment has been received. The entry fee payment must follow the process described in the Official Competition Bulletin. No payment is required for Official Reserves.

Payments must include:

- The event name.
- The Federation making the payment.
- The number of competitors entered.

Payments that do not comply with these requirements will not be considered valid.

Any skier entered as a Wild Card or Individual is also to be considered to be a TEAM reserve.

An entered skier may be replaced by a different one without penalty, provided that they have already been entered as a Reserve skier, wild card or individual.

a) Fines for Late Registration.

Any Federation not meeting the registration deadlines will not be allowed to compete until their Federation pays a fine to the IWWF Representative at the Championships. The fines are as follows:

- * **€ 50** per skier if the registration is made between 44 to 30 days before the scheduled start of the first event of the Championships
- * **€ 100** per skier if the registration is made between 29 to 15 days before the scheduled start of the first event of the Championships
- * **Double the Entry Fee** per skier if the registration is made between 14 days until 12:00 (competition local time), 2 days before the scheduled start of the first event of the Championships

Example: scheduled start of the first event of the Championships is July 31 deadline to register skier is noon 12:00 UTC of July 29.

Two days before the start of the first event the entry lists shall be closed at noon 12:00 (competition local time) and thereafter the order of competitors entered and paid will be finalized and posted.

The Scorer in consultation with the Chief Judge should post Preliminary Running Orders 7 days preceding the start of events with the orders clearly marked as “Preliminary and subject to change”. No change in this order is allowed after noon (competition local time) of the two days preceding the start of events except that a team representative may without penalty:

- 1) Withdraw a skier from the competition.
- 2) Replace an injured skier with a qualified official reserve from the same team with the authority of the Chief Judge and before the start of the first event, that is, before the first skier taking part in the first event has started.
- 3) The substitute skier shall start first in the series in which he is qualified unless the draw has not yet been completed.

b) Team or individual athletes not showing up:

If a team or individual athletes whose Federation has duly submitted a competition entry fail to appear for the competition, the corresponding entry fee shall remain fully payable and no refund shall be granted.

13. OFFICIAL SITE FAMILIARIZATION

The last two days immediately before the Championships (04. / 05.08.2026) will be reserved and used for Official Familiarization. This will be organized so that each competitor who has paid shall be allocated either a set number of passes and/or a certain amount of time at the discretion of the Chief Judge based on the principle that every skier shall receive an equal opportunity for familiarization.

Slalom skiers will receive – 4 passes or 6 minutes whichever is less Tricks skiers will receive – 2 passes or 5 minutes whichever is less Jump skiers will receive – 3 passes or 6 minutes whichever is less

After closure of the EMS 45 days before the Championships each entered competitor will be allocated Official Familiarization time as specified above. 30 days before the scheduled start of the event, the Organizer (in consultation with the Chief Judge, whose decision shall be final) shall announce the official familiarization schedule (including the allowed time).

If a Federation does not want to take part in the Official Familiarization, it must notify the Organizers and the Chief Judge as soon as possible. Time will be scheduled for competitors on a random team basis and shall be grouped by event. Slalom familiarization, Trick familiarization and Jump familiarization (by jump height) will be grouped together. Any athlete whose time has not been paid for at least 30 days before the scheduled start of the event, or who is not ready to ski in accordance with the schedule, will lose their official familiarization time.

The Chief Judge shall have the discretion to change the start time of team’s familiarization based on extraordinary circumstances.

During the Official Familiarization period the Chief Judge may allocate any available site familiarization times but only to skiers who have not already used it or do not have time allocated.

The maximum cost per hour for official familiarization will be € 240,00 (€ 4,00per minute).
