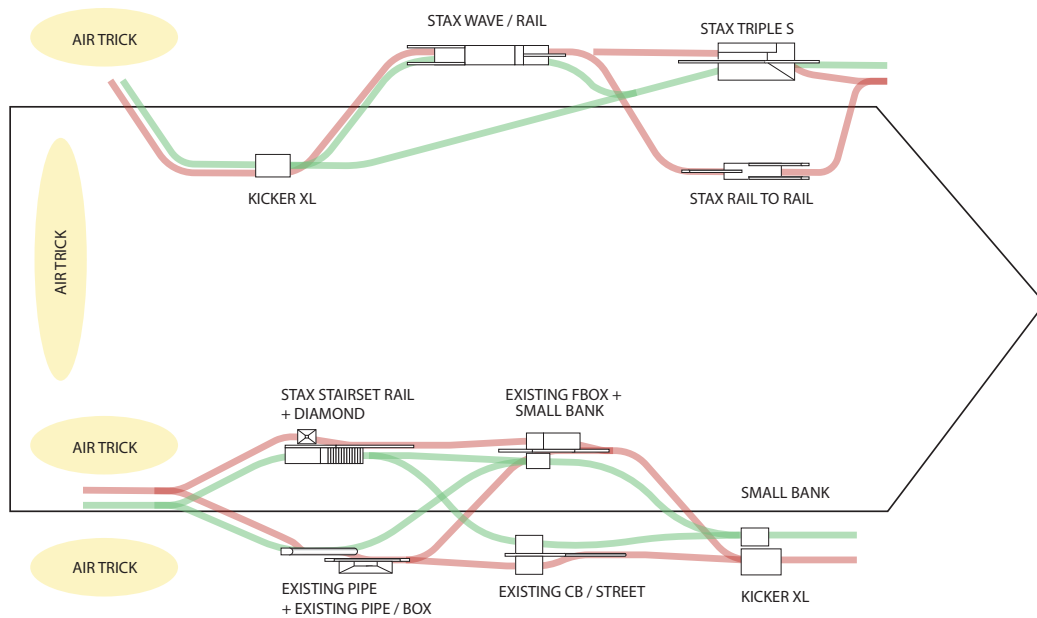

6. TRAVEL

6.1 The IWWF Internal Regulation to the Articles (Article 11.1) state:

It is the responsibility of each Federation when entering competitors for a World Titled Event to ensure that its competitors are adequately insured for accidents, permanent disabilities, death and medical expenses etc.

6.2 Visa

China now offers **VISA Free Entry into China**. Please contact the Chinese Embassy in your respective countries for specific information whether this applies to your Nationality, and send your request for an invitation to <cnwaterski@126.com> by latest 31st May 2026, if one is required. [FAQ on VISA Free Entry into China](#). **Passports must be valid for at least 6 months from the date of entry into China.**

6.3 Airport - [Beijing Capital International Airport \(PEK\)](#)

All teams and officials should make arrangements to arrive and depart from the Beijing Capital International Airport (PEK). The airport is located 20 km / 33-minute drive to the Shun Yi Olympic Cable Park.

6.4 Airport Transfers (to Official Hotels)

Complimentary return airport transfers, from the Beijing Capital International Airport (PEK) to the two Official Hotels, from 6th August until 17th August 2026, will be provided for teams/athletes staying at the Official Hotel. This will also apply to IWWF Executive Board Members, Technical Officials and Members of the IWWF World Cable Wakeboard Council. 6.5 Venue Transfers (Official Hotels to the Event Venue)

The organizer will provide free transportation only from the two designated Official Hotels to the Event Venue starting 8th August to 15th August 2026 for teams & team officials, IWWF Executive Board Members, Technical Officials and Members of the IWWF World Cable Wakeboard Council. The transportation schedule will be announced in due course.

6.6 Taxis

Please contact the hotel manager to request a taxi service. Cash, WeChat pay, and Alipay are accepted.

6.7 Car Rentals

All major car rental companies can be found at both airports. **Participants must have a valid Chinese driver's license to rent and drive a car in China.**

6.8 Currency

The Renminbi (RMB) is the official name of China's currency. The principal unit of RMB is called the Chinese Yuan (CNY). 100 USD = 719.36000 CNY

In China, power plugs and sockets (outlets) of type A and type I are used. The standard voltage is 220 V and at a frequency of 50 Hz




6.11 Tourist Information

Beijing, China's capital for over 800 years, is a city where imperial history and modern life meet. For visitors, it offers some of the world's most iconic cultural landmarks, all closely connected to China's dynastic past.

The Forbidden City is the heart of Beijing and the city's most famous attraction. Once home to 24 emperors of the Ming and Qing dynasties, this vast palace complex features grand halls, ornate courtyards, and priceless artifacts. Today it operates as the Palace Museum and offers deep insight into imperial life and Chinese architecture.

Just south of the Forbidden City is Tiananmen Square, one of the largest public squares in the world. Surrounded by major landmarks such as the National Museum of China and the Mausoleum of Chairman Mao, the square is central to modern Chinese history and national ceremonies.

No visit to Beijing is complete without seeing the Great Wall of China. Popular sections near the city include Badaling, Mutianyu, and Jinshanling. Stretching across rugged mountains, the Great Wall provides breathtaking scenery and a powerful sense of China's ancient defensive engineering.



The Temple of Heaven is another highlight. This UNESCO World Heritage Site was where emperors prayed for good harvests. Its elegant circular halls and landscaped park showcase classical Chinese design and remain a favorite spot for locals practicing tai chi.

For a more traditional atmosphere, visitors should explore Beijing's hutongs—narrow alleyways lined with courtyard homes. Areas such as Nanluoguxiang offer a blend of old Beijing charm, local food, and small shops.

Finally, the Summer Palace, located on the city's outskirts, offers a peaceful escape. With its lakes, marble bridges, and hillside palaces, it served as a royal retreat and remains one of China's most beautiful imperial gardens.

Together, these attractions make Beijing an essential destination for travelers seeking history, culture, and unforgettable landmarks.

8. IWWF SAFE SPORT POLICY & SAFEGUARDING REGULATIONS

The IWWF takes safeguarding extremely seriously and is committed to ensuring that everyone who attends the championships, whether athletes, officials or volunteers are able to operate in a safe environment, free from abuse and the risk of harm. 9. EVENT RULES

All Federations, team managers, team captains and riders should be familiar with the current [IWWF Cable Wakeboard & Wakeskate Rules](#).

9.1 SELECTION

It is the sole responsibility of [IWWF-affiliated National Federations](#) to select and enter their riders.

9.3 MINIMUM REQUIREMENTS AS OF YEAR 2026:

Each Federation can enter maximum 5 riders per gender with no minimum requirements (these riders are referred to as 'wildcards'). Additional entries must meet the following ranking point requirements, on the current [IWWF Cable Wakeboard & Wakeskate Ranking list](#), at the time the competition begins. The entry requirements for the 2026 World Championships are 800 points for U18, Open and +30, and 400 points for all other categories on the rolling CWWC World Ranking list the day the competition starts.

The minimum number of points can be reached by adding points from higher categories, as follows:

- U14 can add points from U18 and Open to be able to start in U14
- U18 can add points from Open to start in U18
- +30 can add points from Open to start in +30
- +40 can add points from +30 and Open to start in +40

Riders competing under the IWWF Flag must have a minimum of 400 Ranking Points to compete.

9.4 FEDERATION MEMBERSHIP

All riders must be members of their respective country's IWWF affiliated [National Federation](#).

How it works: IWWF has a network of [+90 National Federations](#).

Only IWWF-affiliated national federations can submit entries for the IWWF World Championships using EMS. By entering riders for the IWWF World Championships, national federations certify that their respective riders hold a valid membership and insurance policy (which provides international coverage).

Each national federation selects its team and decides on allowing the individual entries. If you are not sure how it works in your country or how to locate your respective National Federation, please contact us and we will provide information.

Exceptions: Riders from countries without a national wakeboard/waterski federation affiliated to the IWWF will be permitted to register to compete in the IWWF World Championships, subject to approval from the IWWF. Please contact us for more information.

9.5 SAFETY

Please note that all riders have to wear helmet and an approved life vest. All participants ride/compete at their own risk.

9.6 Athletes Under 18 years of Age

IWWF Cable Wakeboard Council & Officials follow the [IWWF Safe Sport Policy](#). All athletes under the age of 18 years, must be accompanied at the site by a guardian over the age of 18 years. This guardian will accept parental responsibility for the athlete for the duration of the competition. The IWWF and its officials DO NOT act in loco parentis for any child at an event.

9.7 Entry Procedure & Deadline

Each Federation shall declare, through [EMS](#), not later than **30th June 2026**.

- The names of the members of its team
- The names of the competitors entered as "Individuals"
- The names of the competitors entered as Wild Cards

An entry is considered complete when the Rider's name is registered in EMS and the full Entry Fee Payment has been received. Full payment of entry fees is to be received No Later than 15th July 2026.

No rider will be able to start in the competition if there are any fees outstanding.

Any Federation not meeting this requirement will not be allowed to compete until the Federation pays a fine of USD 10.00 per rider per day after this deadline to the IWWF for each rider not officially entered. Late entries will only be accepted with the mutual consent of the Organizer and Technical Delegate.

If one of your riders is injured and you wish to replace them with a new rider, you will NOT have to pay Late Entry fees for the replacement rider. No refunds will be made for a rider's non-attendance.

9.8 IWWF License

All athletes must be registered by their respective Federations in the IWWF EMS and must hold a valid [licence](#) to compete. Only Federation EMS Users can enter the athletes to participate in the competition in EMS. Please ensure your athletes know who to contact for federation registration.

9.9 Entry Fees

The Entry Fee will be **US\$150.00 per rider** if competing in the Under 14 and Under 18 categories, and **US\$200.00 per rider** if competing in the Seated, Open, Over 30 and Over 40 categories. Entry fees must be paid by bank transfer to Organisers (details at point 20). **The deadline for payment is 15th July 2026**. Please indicate your "Name of Country" and "Entry Fee 2026 IWWF Cable Wakeboard Worlds" when making your transfer.

9.10 Late Entry Fees

The only payment that will be accepted on site at registration, is payment for Late Entry fees charged at USD\$10.00 per day (the maximum charge for late fee will be US\$300.00 per rider).

Note: Before a Federation can register a rider to compete, the rider has to be registered in EMS.

10.1 REGISTRATION CHECK LIST

Team Captain's should ensure their riders have in hand / completed the following before reporting for registration:

- Anti-Doping Consent Form (has to be signed by the Parents or Guardian if under 18 years of age) - APPENDIX A1
- Form for Minors (signed by their Parents or legal Guardian) - APPENDIX A2
- Form for Adults - APPENDIX A3
- Valid passport to show proof of age and nationality (identification cards and driving licenses are insufficient proof)
- Proof of Personal Accident Insurance – to include participation in the 2026 IWWF World Cable Wakeboard & Wakeskate Championships**

Once all riders have completed the above steps, the Team Captain should report to registration with all passports, signed forms and proof of payment to complete registration.

11. RIDERS REPRESENTATIVE ELECTION

RIDERS Representative elections will take place during the championships, further details will be sent out, explaining the process through our social media channels.

12 OFFICIAL TRAINING – Sunday 9th August 2026

Each country will be allocated training times based on the number of riders on their team. The final schedule by country will be published in the evening after the registrations are done.

12.1 TEAM TRAINING

All Riders will start training together during the Rental Hours and are required to book training slots.

- Training slots are available on 4-8th August from 9:00 am – 13:00 pm (4 hours per day for 5 days)
- Each country has 3 credits to book 6 different training slots
- Slots are 60-minute sessions, US\$250.00 per session.
- There will be a maximum of 30 athletes booked onto any session
- Any number of teams can enter a slot.
- The deadline for bookings is 4:00 pm the day before.
- You can only book with a full team of riders who have registered to compete in the event.
- Bookings for training must be made in the spreadsheet provided to the team captains WhatsApp group prior to the event.
- You must pay for the number of slots booked at registration
 - Fees must be paid in Cash at Registration
 - Fees are payable for all slots booked regardless of whether they are used.
 - Fees will only be calculated at registration as it is not possible to work this out in advance due to teams having the ability to change booked slots up until the evening before. However the Team Captain will be able to see the costs on the spreadsheet with the bookings.

13. OFFICIAL FUNCTIONS

13.1 Opening Ceremony

The Opening Ceremony will be held on Saturday, 8th August, in the evening (time to be confirmed) at Shunyi Olympic Cable Park followed by a Welcome Dinner. Free admission will be granted to Athletes, one Team Official per team (or two Team Officials for teams with eight or more athletes), athletes' family members, Technical Officials, and IWWF Executive Board Members. All teams are to be dressed in team uniforms and **attendance is mandatory**.

13.2 Closing Ceremony & Final Night Banquet

The Closing Ceremony and Final Night Banquet will be held on Saturday 15th August (time and venue to be announced), Free admission for Athletes, one Team Official per team (or two Team Officials for teams of 8 or more athletes), Technical Officials and IWWF Executive Board Members
